Does your rate include travel to our location?

What are your payment terms?

For mutual security and convenience, we accept Zelle money transfers on the same day as services are delivered and will provide an itemized receipt. 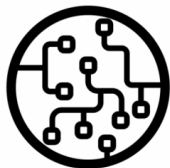
